4.2 Report of President

Ms. Fairclough provided the following comments:

- The region is pretty much in the red zone as it relates to all measures and COVID cases are continuing to rise; the hospital has experienced a rapid increase of COVID positive patients over this past week.
- The hospital has moved into scenario 4a of the "Optimizing Care through COVID-19 Transmission Scenarios" (Ontario Health) framework and will maintain services where we can.
- We have started to initiate some adjustments, including the cancellation of some elective procedures that require an inpatient stay, and we have chosen to keep our day surgeries open for now.
- With regard to care partners, it is the intent to try to maintain access for them at this time; we want them to be involved as long as we can.
- At the Ontario Health (OH) West region table there has been discussion about how hospitals can support each other, e.g., assisting another hospital with cardiac cases, and that we may need to work across broader distances in this regard.
- On Saturday, work with Region of Waterloo Public Health was initiated related to a management order of an independent home; the St. Mary's team and physicians stepped up to support this and we are doing everything to ensure the safety of our staff and the residents of the home.
- The three Waterloo Region hospitals CEOs are participating in a COVID-19 virtual town hall which is scheduled for November 26th at 8:00 p.m. and will be hosted by Rogers TV.

5.0 BUSINESS

5.1 Mission and Governance Committee Report

Mr. Cantin spoke to a few items the Mission and Governance Committee have been discussing and which will be brought forward to the Board as recommendations once work on them has been completed.
